**Active Firefighter Membership Applicants:**

All active members shall be placed on a six (6) month probationary period during which time they shall demonstrate: an active interest in the Company by obeying all the laws and rules, attending 75% of meetings, work and training sessions, and responding to at least 20% of the alarms. At the end of the six months, upon recommendation by the Fire Chief, Secretary and the President to accept or reject, it will be up to the members present to accept or reject full membership. However, should they in the opinion of the Fire Chief, President, Head Trustee, have a serious deficiency of activity, or serious breach of laws and rules, or willful misconduct occur, all membership relations shall be severed at any time during the probationary six months.

**Article II, Section II  
Hyde Volunteer Fire Company By Laws****Administrative Membership Applicants:**

All administrative members shall be of good moral character and of not less than Eighteen (18) years old. Administrative members will not be eligible to run calls or hold a line officers position. Administrative members will be eligible to help with functions, they will have a voice at meetings and be able to hold executive offices, they will not be able to hold any Line Officers, QRS Directors or Truck Foreman positions, nor will they be permitted to run any type of call.

- A. Administrative Members will be placed on six (6) months probation during which the time they shall demonstrate: an interest in the Company by obeying all the laws and rules, attending 75% of meetings and functions.
- B. At the end of the six (6) months, upon recommendation of the President, Secretary and Head Trustee to accept or reject, it will be up to the members present to accept or reject full membership.
- C. However, should they in the opinion of the President, Secretary and Head Trustee have a serious deficiency of activity, or serious breach of laws and rules, or willful misconduct occur, all membership relations shall be severed at any time during the probationary six months.
